Commentary on the Law of the International Criminal Court

Provides provision-by-provision analysis of the Rome Statute and the Rules of Procedure and Evidence of the International Criminal Court and enables searches of case-law, doctrine and comments.



A service of the ICC Legal Tools Project, used in more than 35 countries, it provides legal information on international criminal law, helps organise case files and manage evidence, and contains a database structure for analysis of law and fact in core international crimes cases.

The CMN Methodology

Our work builds on and strengthens the taxonomies developed in the ICC Case Matrix and the ICC Legal Tools Database.

I-DOC builds on logical ideas of the ICC Case Matrix and conceptual discourse in the context of the CMN.



Provides a structure to organise open case files involving core international crimes and gross human rights violations to support better-informed decisions on selection and prioritisation of cases.

- Case-mapping and generation of statistics on the progression of cases as well as bottlenecks;
- Increased information and transparency on existing cases;
- Enabled application of criteria for case selection and prioritization;

DOCF builds on earlier models developed by CMN Advisers, in Bosnia and Herzegovina (through the good offices of the OSCE Mission) and in the Democratic Republic of Congo (through UNOPS).
